



DIRECT RECRUITMENT

Applications are invited in prescribed Form from the eligible citizens of India for selection of candidates for the under mentioned posts under the Government of Tripura :-

Item No.1:-1(one) (UR) Post of Director, Group-A Gazetted-Grade-I(A) of **Animal Resources Development Department**, Government of Tripura scale of pay Rs 24,625-40,600/- Grade Pay Rs.6500/-(Band-HAG+Scale) plus Admissible allowances. **Education Qualification:-**(i)Degree in Veterinary Science from a recognized University.

Desirable(i)-Post Graduate Diploma/Master Degree/Ph.D from recognized University,(ii)Higher study/Training /Assignment abroad for at least **1(one)** year.

Experience:-Minimum of **25(twenty five)** years service under State Government,Central Government, Other organization including at least **5(five)** years at the level of Joint Director/Additional Director.

Age:-50(fifty) years as on **31.03.2010.** Upper age limit is relaxable by 5(five) years in case of SC/ST/PH candidates and Government Servants. Provided that the Govt. Servants belonging to ST, SC & PH categories shall not get this relaxation over and above the general relaxation of 5 years available to them.

Item No.02 : 1(one) (UR) Post of Director, Group- A Gazetted, Directorate of Prosecution under the Home Department,Goverment.of Tripura scale of pay Rs 24,625-40,600/- Grade Pay Rs.6500/-(Band-HAG+Scale) plus Admissible allowances. **Educational qualification: - Essential :- (i)** A candidate must possess a Law Degree.

(ii) He/She must be a practicing Advocate for not less then **15 years**.

Desirable:- Prosecution Lawyer will be given preference.

Age :-40 to 50 years as on **31.03.2010.** Upper age limit is relaxable by 5(five) years in case of SC/ST/PH candidates and Government Servants. Provided that the Govt. Servants belonging to ST, SC & PH categories shall not get this relaxation over and above the general relaxation of 5 years available to them.

Item No.03 : 1 (one) (ST) Post of Deputy Director, Group- A Gazetted in the Directorate of Prosecution under the Home Department, in the Pay Band-4 scale of pay Rs.13575-37000/- Grade Pay Rs.5000/- plus admissible allowances.

Educational qualification: - (i) A candidate must possess a Law Degree. **(ii)** He/she must be a practicing Advocate for not less then 10 years.

Desirable:- Prosecution Lawyer will be given preference.

Age :- 35 to 45 years as on **31.03.2010.** Upper age limit is relaxable by 5(five) years in case of SC/ST/PH candidates and Government Servants. Provided that the Govt. Servants belonging to ST, SC & PH categories shall not get this relaxation over and above the general relaxation of 5 years available to them.

Item No.04 : 3 (three) tmp.(UR) posts of Child Development Project Officer, Group-B Gazetted under the Education (Social Welfare & Social Education) Department in the scale of pay Band-3 Rs.9570-30,000/- with Grade Pay of Rs.3500/- .

Educational Qualification :- Essential :- At least Bachelor Degree of a recognised University.

Desirable :- Knowledge in Bengali or Kak-Borak.

Age:-18 to 37 years as on **31.03.2010.** Upper age limit is relaxable by 5(five) years in case of SC/ST/PH candidates and Government Servants. Provided that the Govt. Servants belonging to ST, SC & PH categories shall not get this relaxation over and above the general relaxation of 5 years available to them.

Other Important information related with all above items:

(1) The number of posts to be filled up is subject to increase or decrease following requirement of the Department.

(2) The last date of receiving application is **31.03.2010.** The application received after the closing date will not be entertained.

(3) **Prescribed Form availability:** The 4(four) pages printed application Form will be available from any of the total 105 Nos. of Branches/Extension counters of **Tripura Gramin Bank** located at different places of Urban and Rural areas in the State of Tripura on deposit of the prescribed **Recruitment Fee through the Special Deposit Slip to the Account No. 14711 in favour of the Secretary, T.P.S.C.** in the same Branch / Extension counter as a single window system without any extra charge/Commission from the candidates.

For the candidates outside of the State, the said prescribed Form can also be down loaded from the Website <http://www.tpsc.gov.in> or <http://www.tripurainfo.com> and in that case, the **Prescribed Recruitment Fee is to be paid in the form of demand draft of any Nationalized Bank payable at Agartala in favour of the Secretary, T.P.S.C.** The said demand draft is to be enclosed with the filled up application form with record in the specified Box on the 1st page of the Form.

(4) **Rate of Recruitment Fees :- Group –A Posts:-Rs.200/=** (Rupees Two Hundred) **only** for General Candidates and Rs.150/= (Rupees One Hundred and fifty) **only** for ST/SC/ BPL card holders/Physically Handicapped Candidates.

Group – B Posts :- Rs.150/= (Rupees One Hundred and Fifty) **only** for General Candidates and Rs.75/= (Rupees Seventy Five) **only** for ST/SC/BPL Cardholders/ Physically Handicapped candidates.

(5) SC/ST Candidates of other States (not recognized by the Govt. of Tripura) should apply for unreserved vacancy as general candidate along with recruitment fee prescribed for general candidates.

(6) The applicants must be in possession of the prescribed minimum qualification(s) for the respective post(s) on the closing date for submission of application as mentioned in the advertisement.

(7) The application in the prescribed form duly filled in by the candidate and **2(two)** copies of recent stamp size photographs of the candidate affixed on the Application and Admit Card along with the copies of self attested certificates as noted in the application form is to be submitted to the Reception Counter of the TPSC Secretariat by **5 PM** of the closing date & to obtain the acknowledgement including Receipt Number.

The candidates who are to sent the application by post, also required to attach to the application; a self-addressed Post-card indicating the Advertisement No., Item No. and name of the post applied for. Application will be acknowledged by the Commission by returning this card to the candidates after indicating the Registration No. allotted to the candidates. No separate acknowledgement other than this card will be sent to them.

(8) The decision of the Commission as to the eligibility or otherwise of a candidate at any stage of the selection process shall be the final.

(9). Date, time and venue of Screening Test / Interview of the eligible qualified candidates will be notified in due course.
